## Section I. Invitation to Bid

### INVITATION TO BID FOR SUPPLY AND DELIVERY OF 8 PIECES HIGH SPEED CIRCUIT BREAKER

The LIGHT RAIL TRANSIT AUTHORITY (LRTA) through its CORPORATE OPERATING BUDGET for CY 2011 intends to apply the sum of THIRTEEN MILLION ONE HUNDRED FIFTY THREE THOUSAND, FIVE HUNDRED TWENTY ONE PESOS AND 60/100 (Php 13,153,521.60) as the Approved Budget for the Contract (ABC) for the Supply and Delivery of 8 pieces High Speed Circuit Breaker. Bids received in excess of the ABC shall be automatically rejected at bid opening.


1. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents.
2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (Revised IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
3. Bid documents will be available for issuance after payment of non-refundable fee of bid documents starting **November 24, 2011**, weekdays only from **8:00 AM to 5:00 PM**, from the **BAC Secretariat c/o Mr. Fidel V. Dones, III** at the Ground Floor, Administration Building, LRTA Compound, Aurora Blvd, Pasay City.
4. It may also be downloaded free of charge from the website of the **Philippine Government Electronic Procurement System (PhilGEPS)** and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

6. **Bid opening** shall be on **December 13, 2011 at 9:00 AM** at the **LRTA Cafeteria, LRTA Line 2- Depot Santolan, Pasig City**. Bids will be opened in the presence of the Bidders' representatives who choose to attend. Late bids shall not be accepted. Bids received in excess of the ABC shall be automatically rejected at bid opening.
7. **LRTA reserves** the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
