Notes and Policies:

- a. LRTA Board Meetings are scheduled every third (3rd) Friday of every month, subject however to availability of members necessary to achieve quurum.
 b. All documents included in the agenda of the LRTA Board Meeting are provided to the Board of Directors three (3) days before the scheduled meeting.
- c. The LRTA Board of Directors had scheduled twelve (12) meetings, three of the scheduled meetings did not push through due to lack of quorum, and nine (9) were actually held. The LRTA Board of Directors acquired 75% of the required number of meetings per year.
- d. All newly appointed Directors undergo orientation program about the overall aspects of LRTA and on matters relative to their duties and functions as Board Member. They are also required on annual basis to attend seminars, trainings and programs relative to Corporate Governnace.
- e. The 21 June 2018 LRTA Board meeting failed to achieve the required number of Board Members present for purpose of qourum, the said members present as a matter of practice constituted themselves into an Executive Committee to discuss and pass upon the items of the Agenda and make recommendations for approval of the Board during its next Meeting in which qourum is achieved.
