| 7:41 AM June 08,2023 | <p>At around 7:41AM The Armed Forces of Philippines-National Capital Region (AFP-NCR) Joint Task Force arrived at LRTA-2 Depot headed by MAJ BENJIE A JIMENEZ with 20 trained personnel for emergency rescue with one (1) ambulance car and one (1) communication van in support and contribution to the Nationwide Simultaneous Earthquake Drill Simulation conducted by Light Rail Transit Authority – Line 2, also three (3) personnel from PNP Substation 8 Manggahan, Pasig City.</p> <p>Prior to the said activity, coordination to all offices including the Operation Control Center was prepared. MS. DONNA JANE ORO set up a Command Post and served as Team Coordinator, MR. WILLIAM WILFREDO S. FLORES served as the Incident Commander and MR. NIXON F. PAGCALIWAGAN as the Ground Commander. Area intended for evacuation was also prepared at the flagpole by the Safety and Security Division Personnel.</p> <p>Chief Safety Officer MR. NIXON F. PAGCALIWAGAN started briefing the safety officers and security personnel on their involvement on the drill. Five (5) security officers equipped with megaphone was assigned to strategic areas to alert/alarm personnel occupying different offices and to assist them to the nearest exit going to the evacuation area.</p> |
| 9:00 AM June 08, 2023 | <p>Around 9:00AM simulation drill started thru the Public Address (PA) announcement by the Operation Control Center (OCC). Loud sirens from megaphones and ambulance served as alarms and were utilized by security personnel. LRTA personnel including Maintenance Transition Team (MTT) and different contractors equipped with safety helmet joined orderly the simultaneous evacuation proceeding going to the evacuation area.</p> <p>AFP Search and Rescue Unit together with SSD Rescue Unit also conducted actual search and rescue of three (3) victims from different areas to the ambulance on stand-by.</p> <p>SSD Rescue Unit:</p> <ol style="list-style-type: none">1. | 9:19AM June 08, 2023 | <p>Chief Safety Officer Nixon Pagcaliwagan gave brief information of the earthquake drill and its importance and goal.</p> <p>At 9:20AM Chief Safety Officer Nixon Pagcaliwagan announced the earthquake simulation drill was completed and all individual employee's advice to return to their respective offices.</p> |

This pertains to the **Nationwide Simultaneous Earthquake Drill** dated June 8, 2023 around 9:00 AM at Administration Building LRT Line 1 Depot, Pasay City which was participated by different division of LRTA including Department of Transportation - Office of the Undersecretary for Railways (DOTr-OUR).

The said activity started by the Siren from Megaphone to alarm as a signal for occupants to leave and proceed to the evacuation area in front of parking area of Administration Building, followed by search in every room of different discipline.
